Membership Categories and Eligibility

- **c) Corporate Member**: Any firm, company, corporate body, statutory company,_educational institution or trust subscribing to the mission of NCQM interested to promote quality may be accepted as Corporate Member.
- **d) Member (Individual)**: Any individual subscribing to the mission of NCQM may be admitted as Member (Individual). Sustaining members for continuous 5 years, may apply for Senior Membership.
- **e) Student Member**: The special category of non-voting members is intended for regular bonafide students of academic institutions and / or for students registered for the NCQM education courses. They will retain membership by paying subscription till they are students. Thereafter they can renew and upgrade as Members without paying admission fee.

Patron for Life

An individual or organization may pay admission fee and Rs. 75,000/-* (Plus 18% GST) at one time and become Patron for life.

Life Members
